3.I FIRST-YEAR One of the most common reasons for student quitting is the lack of integration. For several reasons, they get used to an academic environment or feel they do not fit in. That is why first-year experience programs are commonly implemented by universities who care about student retention. Students who participate demonstrate more positive relationships with faculty, greater knowled and use of campus resources, more involvement in campus activities, and better than their non-participating peers."
